1. Call to Order:

A quorum being present, the meeting was called to order by the President, Stephen Anderson-Lindsay (SAL) at 7:08 pm.

SAL introduced the current Executive and each member in attendance introduced themselves to the group.

4. Fall 2015 Workshop Update:

Sal & WG reported on the Fall 2015 Workshop, held on Friday evening, Saturday and Sunday, October 2 - 4, with Sherman Hines as the presenter. The Sunday was a practical field day. In general discussion it was suggested that it would be preferable to finish the Sunday session by about 4:30 pm, not later as was the case this year.

The financial accounts are not yet fully complete, but this year the WPC did receive the full amount of Grant monies for which it applied to the Yukon Government. The Sunday Workshop did not have full attendance and consequently the revenue was somewhat less than anticipated.

5. **Amendment to By-Laws:**

A proposed revision to the exiting WPC By-Laws regarding the timing of the Annual General meeting had been circulated to all members in advance of the AGM. The proposed revision changed the month stipulated for the AGM from October to November. WG explained that the Fall Workshop was held during October and thus conflicted with an October AGM.

In discussion the wording of the proposed amendment was changed to grant the Executive discretion at selecting a suitable date.

The President, SAL, delivered his 2014/15 Annual Report, a copy of which is attached.

7. **Treasurer's Report:**

The Treasurer, Dan Scarffe, presented the financial reports, as attached. The balance at the end of the WPC's financial year, Jul3 31, 2015, was reported as \$6,975.72. There is an outstanding refund of \$1,855.73 to be paid to the Yukon Government related to the 2014 Workshop, which will be reflected in the 2015/16 financial report.
